0.5. Definitions

Term	Definition				
Aeroplane	means an engine-driven fixed-wing aircraft heavier than air which is supported in flight by the dynamic reaction of the air against its wings.				
Aircraft	means any machine which can derive support in the atmosphere from the reactions of the air other than the reactions of the air against the earth's surface.				
Aircrew	means flight crew and cabin crew.				
Assessment	means an evaluation of the practical skills leading to the issue of the license, rating and/or endorsement(s) and their revalidation and/or renewal.				
Cross-country	means a flight between a point of departure and a point of arrival following a pre-planned route, using standard navigation procedures				
Pilot-in-command	(PIC) means the pilot designated as being in command and charged with the safe conduct of the flight.				
Private pilot	means a pilot who holds a licence which prohibits the piloting of aircraft in operations for which remuneration is given, with the exclusion of instruction or examination activities, as established in this Part.				
Proficiency check	means the demonstration of skill to revalidate or renew ratings, and including				



	such oral examination as may be required.
Renewal	means the administrative action taken after a rating or certificate has lapsed
	for the purpose of renewing the privileges of the rating or certificate for a

0.7. Purpose

This guidance material is intended to provide information on the validation of third country pilot licenses for commercial air transport activities and other commercial activities.

Certificates of validation are issued in accordance with Minister Order No .218, date 29.12.2023 transposing (EU) Regulation No 723/2020 "For the Approval of Regulation for Detailed Rules Regarding Acceptance of Pilot Certificates from other Places".

Note: The approval process typically takes 10 working days. It may be extended, delayed, or cancelled if there is a lack of required documentation, information, or confirmation from the applicant's Competent Authority.

1. VALIDATION OF FOREING LICENSE & QUALIFICATIONS

1.1 Introduction

A pilot License issued in Compliance with the requirements of Annex 1 to the Chicago Convention from those countries that are not EU or ECAA member according to the provisions of the Multilateral Agreement may be validated by Albanian Civil Aviation Authority.

Pilots shall apply to the competent authority of the Member State where they reside or are established. If they are not residing in the territory of the Member State, pilots shall apply to the competent authority of the Member State where the operator for which they are flying or intend to fly has its principal place of business, or where the aircraft on which they are flying or intend to fly is registered.

In cases where the operator's principal place of business is in Albania, or the aircraft is registered in Albania, pilots shall submit their application for validation to the Civil Aviation Authority of Albania.

The period of validation of a license shall not exceed 1 year, provided that the basic Pilot License remains valid.

This period may only be extended once by the competent authority that issued the validation when, during the validation period, the pilot has applied, or is undergoing training for the issuance of a license in accordance with Part-FCL.

The extension shall cover the period of time necessary for the license to be issued in accordance with Part-FCL.

The holders of a License accepted by ACAA shall exercise their privileges in accordance with the requirements stated in Part-FCL regulation.

1.2 Validation Process

For the validation of pilot licenses for commercial air transport and other commercial activities, the holders shall comply with the following requirements, as applicable, for the privileges sought:

(a) complete, as a skill test, the type or class rating revalidation requirements of Annex I (Part-FCL) to Minister Order No. 178, date 20.12.2024, transposing Regulation (EU) No 1178/2011, as relevant to the privileges of the license held;

Note: the examiner for the skill test has to be designated by Albanian Civil Aviation Authority. ACAA may require that the skill test is observed by an ACAA inspector.

(b) demonstrate knowledge of the relevant parts of the operational requirements and Annex I (Part-FCL) to Minister Order No. 178, date 20.12.2024, transposing Regulation (EU) No 1178/2011;

Note: Please contact Directorate of Training and Licensing for the accepted training organizations before conducting any course for this purpose.

(c) demonstrate language proficiency in accordance with Point FCL.055 of Annex I (Part-FCL) to Minister Order No. 178, date 20.12.2024, transposing Regulation (EU) No 1178/2011;

Note: The English language proficiency assessment must be conducted by LABs/ assessors approved by the ACAA, EASA, or the competent authorities of any Member State.

(d) hold a valid Class 1 medical certificate, issued in accordance with Annex IV (Part-MED) to Minister Order No. 178, date 20.12.2024, transposing Regulation (EU) No 1178/2011;

Note: A Class 1 Medical Certificate must be issued by an Albanian AeMC, AME, EASA, or the competent authorities of any Member State.

- (e) in the case of airplanes, in addition to the requirements in points (a) to (d), comply with the experience requirements set out in table 1 to this guidance;
- (f) in the case of helicopters, in addition to the requirements in points (a) to (d), comply with the experience requirements set out in table 2 to this guidance.

1.2.1 Verification of the foreign pilot's licenses and medical certificates

By completing the application form, the applicant authorizes the Civil Aviation Authorities that issued their foreign licenses and medical certificates to provide all relevant information necessary for their application to the Albanian Civil Aviation Authority (ACAA).



1.2.2 Validity of validation certificate

The validation certificate remains valid for the duration of the foreign pilot's license but cannot exceed 12 months from the date of the Part-FCL skill test.

1.2.3 Validity

In accordance with of Minister Order No. 218, date 29.12.2023, transposing (EU) Regulation No 723/2020 "Laying down detailed rules with regard to the acceptance of third-country certification of pilots", Article, 4, point 3.

1.2.4 Extension of Validation

In accordance with Minister order No. 218, date 29.12.2023 Article, 4 point 3, the Civil Aviation Authority may extend the validity only once and only by a maximum of one year, if during the validity period the pilot has applied for a license in accordance with Annex I (Part-FCL) to Minister Order No. 178, date 20.12.2023, transposing Regulation (EU) No 1178/2011 or is undergoing training for the issuance of such a license. In that last case, the extension shall cover the period of time necessary for the license to be issued in accordance with Annex I (Part-FCL) to Minister Order No. 178, date 20.12.2023, transposing Regulation (EU) No 1178/2011.

Note: This guidance does not apply in the case of manufacturer flights and specific tasks of limited duration, provided the applicant is employed directly or indirectly, by an airplane manufacturer and where the privileges are limited to performing flight instruction and testing for initial issue of type ratings, the supervision of initial line flying by the operators' pilots, delivery or ferry flights, initial line flying, flight demonstrations or test flights.
