Subject: On the acceptance of paragliding pilot training organization “Extreme sports club “Sky Riders”- Prilep”, North Macedonia.

Referring to the request with Prot. No. 792 dated 23.04.2019, “Application for acceptance of “Extreme sports club “Sky Riders”-Prilep”, North Macedonia, for the training of Albanian students for paragliding pilots, based on Law No. 10040, dated 22.12.2008, “Republic of Albania Air Code ”, as amended, Minister Order No.195, dated 3.05.2019, “On the approval of the Regulation on conditions and methods of use of hang gliders and Paragliders”, Albanian Civil Aviation has evaluated the applying organization, to ensure that it meets the necessary training standards required by the albanian regulations in force.

For the purpose of evaluating the training organization “Extreme sports club “Sky Riders”-Prilep”, Albanian Civil Aviation Authority, checked and verified the submitted documentation and conducted inspections to this organization, respectively on 3-4 July 2019 and 9-10 January 2020.

From the evaluation and inspection process resulted that:

The training program of the organization, “Extreme sports club “Sky Riders”-Prilep”, organizational structure, facilities, equipment, training instructors as well as record keeping are acceptable, in accordance with the requirements of Minister Order No.195, dated 3.05.2019, “On the approval of the Regulation on conditions and methods of use of hang gliders and Paragliders”, to provide theoretical and practical training for albanian paragliding pilots.

For the above mentioned , the ACAA accepts the “Extreme sports club “Sky Riders”- Prilep”, training organization approved by the North Macedonian Civil Aviation Agency, with Certificate No. TC / PG-05, to provide training for albanian paragliding student, according to the training program, “Extreme sports club Sky Riders- Prilep, paragliding student pilots training program”, for the purpose of:

- Issuance of albanian paragliding pilots license.
- Tandem Rating for albanian paragliding pilots .
- Instructor rating for albanian paragliding pilots.

The declaration for the completion of the training course signed by Accountable manager and stamped by the organization for each student pilot and a pilot log book filled with detailed exercises and maneuvers for all the flight instructions signed by the instructor and stamped from the organisation, shall be sent officaily to the ACAA.

Acceptance of the training organization “Extreme sports club “Sky Riders”- Prilep”, North Macedonia, will remain valid as far as, the Certificate of approval issued by the North Macedonian Civil Aviation Agency, with No. TC/PG-05, datë 25.11.2019, is valid and is not subject to variation, suspension or revocation.
